LETTER FROM THE BOARD CHAIR & FOOD BANK PRESIDENT

Dear Friends of the Food Bank,

Thank you for helping us respond to the most dramatic increase in food insecurity in modern times. Thanks to you, by the end of the year, 900,000 people in Los Angeles County received monthly food assistance. Your partnership prevented children, seniors, families and individuals from going hungry.

The COVID-19 pandemic created challenges worldwide, and here in Los Angeles County, we saw high levels of unemployment as entire industries felt the impact of the virus. The number of people coming to the Los Angeles Regional Food Bank and our Partner Agencies tripled in just a few months.

Thanks to generous donors and strong partnerships, the Food Bank was able to respond quickly and efficiently. Our gleaning and distribution processes rapidly transformed to meet new public health requirements and provide easier options for our Partner Agencies, such as the pre-packing of emergency food kits. Our Mobile Food Pantry distributions converted into “mega” drive-through distributions. We created a new delivery program to provide vulnerable populations, such as older adults, with kits delivered to their doorsteps.

Your support also allowed us to address urgent infrastructure needs. Even before the dramatic surge in demand, our warehouse space - already nearing capacity - increased significantly, thanks to the purchase of an additional facility in the City of Industry. After necessary renovations, this facility will allow us to address the critical issue of food insecurity in Los Angeles County more effectively.

We believe that no one should go hungry in LA County - not in regular times, and not during a natural disaster, such as a fire, earthquake or pandemic. Your generous and inspiring action during this critical time is more meaningful than you know. Not only did you make an immediate difference for people who would have otherwise faced hunger, but you also showed LA County that when times are hard, we can come together as a community to provide for one another.

On behalf of the entire Food Bank team and the people we serve, thank you for taking action in one of the most critical times in modern history.

THE COVID-19 PANDEMIC AND RELATED ECONOMIC FALLOUT GENERATED UNPRECEDENTED LEVELS OF DEMAND FOR FOOD ASSISTANCE.

Food Banks are critical resources in normal times and even more so in times of disaster. Fires, earthquakes, pandemics and other unexpected situations can increase the demand for food assistance suddenly, as evidenced by the COVID-19 pandemic.

The Food Bank's Mobile Food Pantry distributions transitioned to a drive-through format in order to reduce the risk of the virus transmission. These distributions also helped to take pressure off of our Partner Agency Network, where the majority of our food volume is distributed. Throughout 2020, COVID-19 mobile distributions were held throughout LA County from the Antelope Valley to Long Beach, Pomona to West San Fernando Valley and everywhere in between.

At the peak of the pandemic in 2020, food distribution increased 145% when compared to the pre-pandemic period. While continuing our daily work to provide much-needed food throughout our community, the pandemic created a dramatic increase in the number of people coming to the Food Bank and our Partner Agency Network for assistance, including many people who were seeking food assistance for the very first time. More than 1.8 million emergency food boxes were distributed in 2020 in response to the unprecedented demand for food by families and individuals.

INVESTING IN LA COUNTY'S FUTURE GENERATIONS

Los Angeles County is home to more food-insecure children than any other county in the United States and 2020 was especially difficult for families with children.

The Food Bank operates a number of Children's Nutrition Programs, including the Backpack, Children's Breakfast, After-School Meals, and Summer Lunch programs, which were forced to adapt with the onset of the pandemic. In 2020, the Food Bank worked with local school districts to supplement their "Grab and Go" meal distribution sites with fresh produce, dairy, meat and other food boxes, helping families struggling to feed themselves.

Before being laid off from her position at the airport, Rose was making \$20 per hour and, although she lived paycheck-to-paycheck, she had a full pantry. After the pandemic hit, she and her children lived "box-to-box." Without these emergency food kits, it is unclear where Rose would have received sustenance for herself and her children. Fortunately, she was able to receive Food Bank Emergency Kits from our Partner Agency, the Salvation Army.

PROTECTING VULNERABLE POPULATIONS

When stay-at-home orders for seniors went into effect in March 2020, the Food Bank teamed up with other organizations to launch a home delivery program and supplement distributions of LA County senior meals with additional food items. Many older adults living on a fixed income are particularly vulnerable to food insecurity, even before the pandemic.

The Food Bank operates Senior Nutrition Programs to help older adults save money so they don't have to skip meals to afford rent, utility bills or medicine. In 2020, the Food Bank distributed more than 311,000 Senior Nutrition food kits. We also launched the second phase of our Senior Expansion Program to increase both the food distributed to older adults and the capacity of our Partner Agencies serving a high percentage of older adults.

ABC7 AND THE LOS ANGELES RAMS SPOTLIGHT

Early in the pandemic, ABC7 and the Los Angeles Rams helped organize a “TeLathon” designed to generate financial support for the Food Bank and energize the community to get involved in pandemic hunger relief. LA Rams players, Riot Games, Edison International, and many others made substantial financial contributions during this virtual event. The telethon was recognized by the *Los Angeles Business Journal*, receiving the “**Outstanding Collaboration Between a Business and a Nonprofit**” award for 2020.

In addition to the telethon, the LA Rams partnered with the Food Bank on the fifth annual Taste of the Rams event in 2020. Chef Steve Samson prepared a delicious meal kit that was delivered to attendees, and Honorary Chair, Cooper Kupp and his teammates talked about football and their commitment to fighting hunger. More than 400 guests participated in the virtual event, which raised more than \$100,000 for the Food Bank.

RWQUARANTUNES

Two of Richard and Demi Weitz’s RWQuarantunes events benefited the LA Regional Food Bank. Early in the pandemic, the pair raised more than \$340,000 for pandemic response. Early in 2021, they teamed up with the Los Angeles Dodgers Foundation to raise more than \$1.1 million.

SEASON FOR SHARING: VIRTUAL DINNER

At the 2020 virtual rendition of the 18th annual Season for Sharing event, emcee, Billy Harris, guided attendees through their delicious meal provided by some of Los Angeles’ Top Chefs. The event honored Food Bank donors, individuals and organizations that have made significant contributions to the fight against hunger in Los Angeles County. The event generated \$145,000 to help the community.

FOOD FROM THE BAR

The 12th annual Food From The Bar campaign raised more than \$600,000 for the Los Angeles Regional Food Bank in 2020. Thanks to Los Angeles’ generous legal community, the Food Bank was able to provide more than two million meals to those facing food insecurity throughout Los Angeles County.

The LA Regional Food Bank works with 700 Partner Agencies to provide nutritious food throughout LA County. The Partner Agency Network, a critical component in the fight against hunger, truly stepped up during this dramatic increase in the need for food assistance.

IMMANUEL PRESBYTERIAN

One of the Food Bank's Partner Agencies, Immanuel Presbyterian in Koreatown, scaled up from one weekly food distribution to six when two other agencies in their neighborhood had to suspend operations due to COVID-19. The number of people they have helped at weekly distributions increased from 120 to more than 1,000 in just three weeks. Virginia Beaboa, Director of Operations, sees the food distributions as a way for the Church to meet the needs of the community. "We wanted to step up and meet the gap," Beaboa said. "I have seen – especially in the past several weeks – just relief on their faces when we are able to help them meet a need for their families, their kids and their elderly."

Thanks to your continued support, the Food Bank is able to provide continuous support to this Church and other local Food Pantries experiencing higher need.

BUILDING HOPE

The Campaign for a Brighter Future

In 2019, the Food Bank launched a \$165 million comprehensive campaign to increase distribution, expand programs and acquire a new facility. In the summer of 2020, the Food Bank acquired a 256,000 square foot facility in the City of Industry, and immediately put the facility to use to help address the high levels of need in our community.

Now, the facility is being renovated to convert it from a warehouse to a state-of-the-art food distribution center, which will allow the LA Regional Food Bank to help more people than ever before.



BUILDING HOPE: The Campaign for a Brighter Future was launched to raise \$165 million by 2022. Contributions to the Campaign will provide the support necessary to increase the volume of food provided throughout LA County and increase the number of people we reach each month, ideally until our vision is achieved: no one goes hungry in LA County.

Our new building in the City of Industry will allow the Food Bank to help more people than ever before. The Food Bank will have the capacity to expand essential programs that combat food insecurity and hunger. Initial renovations include developing a Volunteer Center and Nutrition Center, building a Refrigerated Loading Dock, purchasing a New Fleet of Delivery Trucks and expanding our Partner Agency Network.



