### Letter From the Los Angeles Regional Food Bank Board Chair and President

Dear Friends of the Food Bank,

During the year 2021, the Food Bank continued to face numerous challenges related to responding to the pandemic. The demand for food assistance remained at a record level throughout Los Angeles County. Thanks to strong support of food, volunteer, in-kind and financial contributions, the Food Bank was able to continue to reach an average of 900,000 people every month throughout 2021.

Working with many partners, the Food Bank distributed more than 133 million pounds of food and product, valued at \$200.9 million, to millions of families, older adults, children and individuals seeking assistance. The bottom line of our collective effort is to ensure that our neighbors don't experience the devastating impact of hunger.

Our partnerships with the State of California, the County of Los Angeles, local cities, school districts and other organizations continued to strengthen during 2021, allowing us to reach more of our neighbors struggling to feed themselves and their families, especially in communities that have been disproportionately impacted by the pandemic.

The Food Bank continued to increase the capacity of our more than 600 partner agencies by purchasing refrigerated vans and trucks, commercial refrigerators and freezers and other equipment needed for their sites. This increased capacity allows our partner agencies to acquire, store and distribute more perishable, frozen and other foods, helping more people seeking food assistance in their community. Our Extra Helpings Program continues to be an efficient food recovery model for our partner agencies to access nutritious food in their neighborhoods and distribute the food to people in need.

In 2019, the Food Bank launched a Comprehensive Campaign to pay for the acquisition of a 256,000 sq. ft. building in the City of Industry, the building improvements required for the building and for the Food Bank's ongoing operations and programs. As of December 2021, we have raised \$141 million of the \$165 million goal, and we expect to reach our goal by the end of 2022. The Industry building has been critical to our pandemic response, and once the refrigeration and pallet racking has been installed and other improvements are made, this building will significantly increase the Food Bank's capacity to serve the community.

We are heartened that we live in a community of so many generous people like you who have made hunger relief a priority, giving others hope for a better and brighter future. Thank you for your support of the Food Bank as we continue to mobilize resources to fight hunger in our community.

- Source and acquire nutritious food and other products and distribute them to people experiencing nutrition insecurity through our partner agency network and directly through programs;
- Energize the community to get involved and support hunger relief.
- Conduct hunger and nutrition education and awareness campaigns and advocate for public policies that benefit the people we serve.





Our ongoing pandemic relief continued in 2021, but new challenges emerged, including rising prices of everyday essentials, which exacerbated food insecurity in Los Angeles County. Serving communities from the Antelope Valley to Pomona to the South Bay, the Food Bank provided hundreds more of the drive-through distributions that were crucial at the pandemic's peak. Combined with the everyday work of the Food Bank, these ongoing COVID-19 relief distributions reached millions of individuals and provided nutritious food when it was needed most.

Thanks to the support of our generous community, between March 2020 and December 2021, 289 million pounds of food, or 235 million meals and other essential items, were distributed to our neighbors in need.



Los Angeles County is home to more foodinsecure children than any other county in the United States. Experts report that students who experience food insecurity are more likely to suffer psychologically and academically. Keeping up with essential costs can be difficult for families, especially when school is not in session.

Alondra Flores, mother of three living with a total family of six, didn't anticipate getting into an accident that temporarily immobilized her, impacting her job and ability to provide for her family. She turned to Food Bank partner agency, Central City Neighborhood Partners (CCNP), to

access nutrition assistance for her family every week. When she had surgery and was bedridden, CCNP continued assisting by directly distributing food to her children. "I really don't know how we would have gotten through it," she said. "A family of six is a big thing, and the expense is pretty big. No one is prepared for an accident like that. Nobody really prepares for an accident."

With your continued support, the Food Bank and our partner agencies were able to provide food assistance to about 12,000 food-insecure children in LA County.

"This support is not just for me; it's for many people and for many children whose parents do not have sufficient resources to cope," Flores said. "I am very happy and grateful to everyone, CCNP, organizations, and everyone who is supporting us in this situation."

### **Serving Vulnerable Populations**

The pandemic reminded everyone that the senior community is one of our most vulnerable. Many older adults who live on a fixed income are forced to make sacrifices in an effort to make ends meet. This often means having to decide between food, utilities or medicine.

The Commodity Supplemental Food Program (CSFP) is one of the largest programs of its kind. In 2021, CSFP distributed more than 329,000

food kits, serving an average of 28,000 seniors every month at 110 sites throughout the county.

Older adults were especially vulnerable during the COVID-19 pandemic. Thanks to our generous donors, volunteers, supporters and partners, the Food Bank was able to reach older adults in need through a delivery program as they stay safe at home.

A food recipient and recent widow at Food Bank partner agency Interfaith Food Center (IFC) in Santa Fe Springs explained how IFC staff and volunteers helped him through this trying and devastating time. For him, a distribution is "more than just a food program."

The 6th Annual Taste of the Rams virtual event brought together 500 hunger-relief advocates to benefit the Food Bank. The funds raised will help provide the equivalent of nearly one million meals for those experiencing food insecurity in LA County. ### **Season for Sharing**

The 19th Annual Season for Sharing was held virtually for the second year in a row with returning event producer Paul Vitagliano and host, Billy Harris, navigating guests through a specially-curated multi-course meal presented by award-winning chef and restaurateur Timothy Hollingsworth of Otium. The event celebrated many different hunger relief advocates, from donors and individuals to community partners who helped to alleviate hunger in LA County throughout the year.



#### **Food From the Bar**

The 13th annual legal community Food From the Bar campaign raised nearly \$625,000 for the Los Angeles Regional Food Bank in 2021. This generous donation will help the Food Bank and our partner agency network provide more than 2.5 million healthy meals to families and people throughout Los Angeles County.



#### Feed SoCal

The LA Regional Food Bank teamed up with ABC7, Albertsons, Vons, Pavilions, Subaru, ESPN LA 710, generous shoppers and donors for the 10th Annual Feed SoCal Food Drive Event. The event raised \$77,225 and more than 28,000 pounds of food, helping to provide up to 3.6 million nutritious meals.





The majority of the Los Angeles Regional Food Bank's food and grocery products are distributed through a network of 600 partner agencies. One of those agencies is Eastmont Community Center.

When Brenda Mata was eight years old growing up in East Los Angeles, she recalls someone coming over to visit them around the holiday season. The stranger was delivering a box full of toys, food, snacks and pizza — an all-time favorite among children. She and her brother were excited to receive such a generous gift.

Growing up, Mata didn't realize her family was food insecure. Her parents made sure that their children were fed and full every day, but they themselves would, at times, go to bed or work hungry and with the lingering thought of whether or not they would be able to provide a meal for their children the next day.

Years passed, and Mata became a teacher.
Looking to give back to her community, Mata was presented with the opportunity to become the Program Coordinator at the Food Bank partner agency, Eastmont Community Center, and without hesitation, she accepted the position.



### Partner Agency Highlight

"I just remember kind of catching myself – I didn't even know," she said. "I ended up in the same place that helped us. For me, it's always been important to give back."

Not only does the LA Regional Food Bank provide food and grocery items throughout the partner agency network, but it also provides equipment, such as refrigerators, trucks, pallet jacks, volunteers and other essentials.
